Instructions for the DSM-5-TR Addendum to the Titanium Software License Agreement

You only need to sign and return this addendum if you are licensing the optional DSM-5-TR codes. All terms and conditions in the Titanium Software License Agreement apply to this Addendum.

Why do we require this Addendum?

As part of Titanium's agreement with the American Psychiatric Association to incorporate parts of the DSM-5-TR in our software, they require us to have our customers sign an agreement with this additional language to help protect the copyright on the DSM-5-TR.

Name of licensee:

The large underlined spot at the top of the agreement is where you enter the name of your school/company. That name will also go in the "Licensee" field in the signature block at the end of the agreement.

Signatures:

The Titanium Software License Agreement should be signed by an authorized representative of your school/company. Usually this is someone from the purchasing department or an officer of the school/company like the VP of Student Affairs. Please note that not all employees of a school/company have the legal authority to sign this legally binding license agreement.

Addendum to the Titanium Schedule Software License Agreement User Agreement for the DSM-5-TR Licensed Materials

This License Agreement (the "Agreement") is between **Titanium Software, Inc.** ("LICENSOR") and _____ ("LICENSEE").

1. DEFINITIONS.

APA - American Psychiatric Association

DSM-5 License Material - DSM-5-TR Classification (Codes and Disorder Names Only)

SOFTWARE – The Titanium Schedule software package that includes the DSM-5-TR Licensed Material.

USER - A named individual who (a) accesses, uses, or manipulates DSM-5-TR contained in the PRODUCT; or (b) accesses, uses, or manipulates the PRODUCT to produce or enable an output (data, reports, or the like) that could not have been created without DSM-5-TR embedded in the PRODUCT even though DSM-5-TR may not be visible or directly accessible.

2. **GRANT OF LICENSE.** This Addendum grants the LICENSEE a nontransferable, nonexclusive right to use the DSM-5-TR codes and descriptions in the SOFTWARE in centers located in the United States, Canada and Australia. The DSM-5 TR License is issued for one (1) consecutive twelve (12) month period. After that time, the License may be extended by mutual agreement of the parties. This Addendum shall automatically terminate if a newer edition of the DSM-5-TR is replaced by future editions / versions of the Diagnostic and Statistical Manual of Mental Disorders.
3. **LICENSING FEES.** Current pricing can be found on TITANIUM's website (www.TitaniumSchedule.com). LICENSEE shall pay to TITANIUM the licensing fees in the invoice provided to LICENSEE.
4. **RESTRICTIONS.** LICENSEE is prohibited from distributing, publishing, translating, or transferring possession of the SOFTWARE or the DSM-5-TR License Material. LICENSEE is prohibited from creating derivative works based on the DSM-5-TR, or selling, leasing, or licensing it or otherwise making it available to a non-authorized party. Any person who uses the SOFTWARE is also required to comply with this Addendum.
5. **COPYRIGHT AND NOTICES.** LICENSEE acknowledges the copyright to the DSM-5 TR is owned by APA. LICENSEE will not alter or delete the DSM-5-TR copyright information embedded in the SOFTWARE.
6. **DISCLAIMER OF WARRANTIES. LICENSOR EXPRESSLY DISCLAIMS AND EXCLUDES ALL WARRANTIES (INCLUDING WITHOUT LIMITATION, MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE) AND REPRESENTATIONS, WHETHER EXPRESS OR IMPLIED, IN RELATION TO LICENSEE'S USE OF THE WORK IN ITS PRODUCT.**

LICENSOR WILL NOT BE LIABLE TO LICENSEE, OR ANY THIRD PARTY FOR LOSS OF PROFITS, LOSS OF USE OR FOR ANY INDIRECT, SPECIAL, OR CONSEQUENTIAL DAMAGES WHETHER BASED UPON A CLAIM OR ACTION OF CONTRACT, WARRANTY, NEGLIGENCE, STRICT LIABILITY OR OTHER TORT, EVEN IF IT IS AWARE OF THE POSSIBILITY THEREOF. LICENSEE AGREES THAT THE ENTIRE LIABILITY OF LICENSOR WILL IN NO EVENT EXCEED AN AMOUNT EQUAL TO THE FEE PAID FOR THE LICENSE.
7. **DISCLAIMER OF MEDICAL LIABILITY.** DSM-5-TR is not a substitute for, is not designed to, and does not provide, medical advice. It is a guide for clinicians. Every clinician should use his or her own medical judgment and skill in diagnosing mental illness. LICENSOR shall not be liable to LICENSEE or any third party if readers of DSM-5 TR disregard professional medical advice, or delay in seeking such advice, because of something they have

read in the DSM-5 TR. LICENSOR shall not be liable to LICENSEE or any third party if readers rely solely on information in DSM-5-TR in making diagnosis, or in place of seeking professional medical advice. RELIANCE ON ANY INFORMATION CONTAINED IN DSM-5-TR IS SOLELY AT THE READER'S OR USER'S OWN RISK.

Moreover, LICENSOR is not responsible or liable to LICENSEE or any third party for any advice, course of treatment or diagnosis provided by a physician or other health care professional. LICENSOR neither recommends nor endorses any specific tests, products, procedures, opinions or other information that may be recommended to a reader or USER by a health care professional.

8. **TERMINATION.** LICENSOR shall have the right to immediately terminate this Addendum by providing written notice of such termination to LICENSEE in the event that LICENSEE fails to abide by any of the terms and conditions of this Addendum or the Software License Agreement for Titanium Schedule, or in the event of termination of APA's agreement with LICENSOR. This Addendum shall automatically terminate if a newer edition of the DSM-5-TR is replaced by future editions / versions of the Diagnostic and Statistical Manual of Mental Disorders.

LICENSEE shall have the right to terminate this Agreement with thirty (30) days of notice by sending LICENSOR a letter stating that LICENSEE is terminating this Agreement and specifying the date LICENSEE will stop using the DSM-5-TR.

Termination of this Agreement will result in the DSM-5-TR feature in the SOFTWARE being disabled. Previously entered DSM-5-TR information will still be visible.

9. **SEVERABILITY.** If a term or condition of this Agreement is found by a court or administrative agency to be unenforceable, the remaining terms and conditions will remain in full force and effect.
